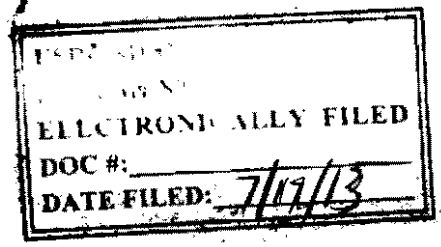

Dear Judge Hellerstein:

I am writing on behalf of the parties in the above-captioned matter. On July 8, 2013, the parties submitted a joint letter to the Court regarding several discovery impasses. Some of the exhibits to the letter have been marked "confidential" under the terms of the parties' protective order, and accordingly, the parties also submitted a Joint Motion to Seal. Doc. No. 171. The motion sought only to comply with the terms of the protective order; if a party wishes to maintain any documents under seal, it must make a submission to the Court within 10 days. The deadline for such submissions with respect to the July 8 joint letter exhibits is July 18, 2013—the day before the parties' scheduled hearing on the joint letter.

In the past, the Court has heard arguments regarding sealing during the Court's hearing on the corresponding substantive filing. *See, e.g.*, Doc. No. 108. The parties respectfully request that the Court do so here, and entertain any arguments regarding sealing at the hearing on July 19, 2013.
