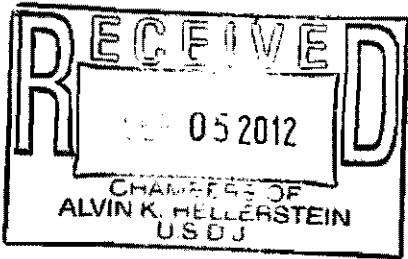
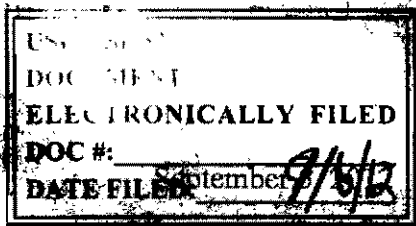

Dear Judge Hellerstein:

Pursuant to Rule 1.D of your Individual Rules, I write to request an adjournment of the status conference scheduled for Friday, September 14, 2012 at 10:00 AM. At the conclusion of the previous status conference on June 1, 2012, the Court scheduled the September 14 conference on the assumption that document discovery would be completed by that date. The parties are working cooperatively on certain outstanding discovery issues, but we anticipate that another 60 days will be needed to complete Pfizer's supplemental production of documents. Therefore, we respectfully request that the September 14 status conference be rescheduled for mid-November. If any disputes between the parties arise in the interim, we will apprise the Court. Plaintiffs' counsel joins in this request.

Status Conf is adjourned to Nov. 16, 2012, 10⁰⁰ a.m. 9-6-12


